  - Finance update:
    - September close, \$37,000
      - TYD: \$384,000
    - Typical revenue: \$400,000 \$500,000, so on track to hit our target
    - No bottom line yet on annual expenses
      - (1) Pay rent, alcohol, labor (etc. host, DJs)
      - (2) About 40% is labor
      - (3) About 30-35% is alcohol
      - (4) Remaining amount is other miscellaneous revenue
      - Member questions: want to have financial talking points
    - Loan application
      - Loan fund: submitted an application this last Sunday for a loan of \$25,000
      - Funds would be used for accounting services, policies and procedures, bylaws, expanding and strengthening our programming, can be used for facilities
      - Can be used to boost our year over year revenue
